Maynooth University Social Sciences Institute (MUSSI) 3 artists/creative writers-in-residence

ERC-funded project Data Stories:

Telling Stories About and With Planning and Property Data

About the Residency

Applications are invited by artists and writers of established reputation for three positions to work on the Data Stories project. All three positions run from January 2025 to December 2025, with duties expected to average 3 days a week working on two case studies, each running in parallel for the twelve months. We have a broad view of what constitutes an artist or creative writer and will consider applications from the full spectrum of artists, including performance and installation artists and digital and media artists, craft workers, novelists, short story writers, playwrights, poets, cartoonists, essayists, and film and documentary makers. The 2023-24 artists-in-residence have been working on the first 6 case studies, the new cohort will work on the remaining 6 cases.

The work associated with the positions is:

- 1) To work on two of the Data Stories case studies.
- 2) To aid the research team to produce data stories relating to planning and property in Dublin.
- To produce at least one data story for each case study through the artist/writer's own creative practice, drawing on the case study research findings and planning and property data relating to Dublin.
- 4) To produce at least one data story for each case study in collaboration with a sector stakeholder and research team using a research creation approach. This will involve several meetings with the stakeholder and researchers and running at least two workshops per case study.
- 5) To help with the artistic direction in public exhibitions of the produced data stories.
- 6) To document their creative practice on the project work, take part in interviews with the research team about the process of producing data stories, and discuss their experiences and viewpoints at public events relating to the project.

A contract-for-services fee of €32,000 inclusive of expenses is offered for the 12 month period, with €16,000 payable for each case study. The candidate will be a self-employed person for tax purposes in Ireland and will be solely responsible for all income tax, PRSI and other such payments due in respect of the remuneration paid. Payment of fees will comply with the University Finance rules.



Overview of the Data Stories project

The key idea of the Data Stories project is to focus critical attention on the underlying evidence base for planning and property activity (see https://datastories.maynoothuniversity.ie/). Planning and property data are a key to how cities are understood and managed. They inform government policy, shape public perception, and guide billions of euros of investment relating to land use and development, public and private housing, homelessness, commercial real estate, and infrastructure. Yet, relatively little close, critical attention has been paid to such data beyond some technical considerations related to data access, coverage, quality and interoperability. The Data Stories project is addressing this lacuna by undertaking a five year programme of research in order to examine the data politics, praxes and power operating within the planning and property domains. It is divided into two phases.

Phase 1 of the Data Stories project has sought to map the planning and property data ecosystem for Dublin – all the databases, their content and their interconnections across state, business, civic society stakeholders, including transnational exchanges, and interviewing key actors about their data work and experiences. The aim has been to chart what data are generated, how they are processed, shared, and governed, and to identify any gaps. To date over 120 formal interviews have been conducted, over 60 additional meetings with stakeholders have been undertaken, and a number of audits conducted.

Phase 2 consists of 12 case studies that are either working more closely with sector stakeholders to understand their data practices, governance and use, or examining particular housing and planning issues in more depth by working with relevant stakeholders. Phase 2 is using a mix of traditional social sciences methods (such as interviews, focus groups, observation of data generation procedures, walk-through interviews of data practices, in-situ ethnographies), but also research-creation methods utilising fiction and art practices (e.g., improvisational writing, word play techniques and facilitated conversations, and data art workshops that utilise data visualisation, physicalisation and creative media techniques). Half of the case studies will produce data stories about, and half data stories with, planning and property data.

Information Session

We will hold an information session on the project and posts where prospective applicants can find out more about the expected work and can ask questions. Who May Apply ?

To be eligible to apply, applicants must have:

Essential

- An established track record of artistic or writing practice, including public exhibitions and published work.
- A commitment to using creative practice to explore social, political and technical issues.
- Excellent interpersonal skills and the ability to be an active workshop facilitator.



- Experience of working collaboratively on creative practices with community members or professional stakeholders.
- Good project management skills, including an ability to seed, develop and organise researchcreation workshops, manage workloads and timetables, and meet deadlines.
- Good communication skills and ability to present and discuss their creative practice with the public.
- Ability to work autonomously and responsibly to meet project goals.

Desirable

- Experience of employing a research-creation approach and producing data stories.
- Experience of reflecting on housing, planning, property issues.
- Experience of handling and working with planning, property or spatial data more broadly.

It is expected that interviews will be held in Mid-September 2024.

Terms and Conditions

The posts are expected to average 3 days a week of work to undertake the prescribed work. A plan of action and deliverables will be agreed with the project director at the start of each case study and the work will be assessed every three months to monitor progress and to evaluate the process, the success of endeavour, and lessons learned.

Delivery of each case study has a payment of €16,000 (total €32,000 for two case studies), including expenses (e.g., materials, equipment, consumables, travel). The payment of the fee for each case study will be every two months.

The candidate will be a self-employed person for tax purposes in Ireland and will be solely responsible for all income tax, PRSI and other such payments due in respect of the remuneration paid. Payment will be VAT exempt and cannot be made to a 3rd party on the contracted person's behalf. Payment of fees will comply with the University Finance rules.

The artists and writers will need to interact regularly in person with the research team and with the stakeholders. They do not need to live in Dublin, but must be prepared to visit regularly during the case study fieldwork and to facilitate the workshops.

The project will provide some support for the work undertaken in terms of helping with accessing data and the use of specialist equipment already owned by the project. The organisation costs for the research-creation workshops (e.g., room hire, catering) will be provided by the project. The project will also procure exhibition space for the works produced and help defray publication costs where possible.

The artists and writers will maintain the intellectual and creative rights to the works produced through the commission. Maynooth University and the project will have the right to publish about the commissioned work and the process of working with the artists and writers, to display images of the commissioned work in publications, and to exhibit the works in public exhibitions. In addition, the artists and writers must comply with Article 16 (intellectual property rights) of the EU Annotated Model Grant Agreement (https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/common/guidance/aga_en.pdf).

Display and publication of the produced works must acknowledge the project funding, including the logos of Maynooth University, the Data Stories project, and the European Research Council and European Union.



The University has the right to terminate the contract due to poor or non-delivery of the case study work.
