The Role

Maynooth University seeks an outstanding academic to join our staff as Professor of Educational Psychology, with the initial five year period spent at Programme Director, for the newly established Professional Doctorate in Educational Psychology which is co-led by the Departments of Education and Psychology. The Professional Doctorate in Educational Psychology is a three-year, full-time professional programme which has been developed in close collaboration with the National Educational Psychology Service (NEPS) to prepare graduates to work as educational psychologists in a wide range of settings.

We seek applicants with extensive experience of research and practice as educational psychologists who can bring vision, dynamism, and inclusive leadership to the programme. The person appointed to this role will be expected to serve as Programme Director for an initial period of five years and for regular periods thereafter as determined by the Heads of Departments. As Programme Director, they will take on a leadership role and be responsible for the delivery and management of the Doctorate in Educational Psychology programme together with a dedicated programme team. In addition, there will be sessional input from NEPS staff, other service providers, and adjunct lecturing staff. This is an exciting opportunity to contribute to and shape the growth and direction of Educational Psychology in Ireland.

The person appointed will have an excellent record in research, scholarship and publication, in teaching and educational innovation, and in academic leadership. They will be expected to make a strong contribution to the teaching, research and profile of the university, and to provide ongoing leadership for the discipline.

Maynooth University is committed to a strategy in which the primary university goals of excellent research and scholarship and outstanding education are interlinked and equally valued. Professors will be expected to provide significant intellectual leadership, through a demonstrated commitment to both education and research, and also to contribute to the effective leadership and management of the department, the faculty and the university.

Principal Responsibilities

A Professor of the University is expected to:

- Be an international leader in research and scholarship and contribute to the advancement of knowledge in the field;
- Provide leadership in research and scholarship within the Department, Faculty and University;
- Promote excellence in teaching and learning, and encourage innovation in teaching and learning amongst staff;
- Contribute to the teaching of undergraduate and postgraduate students, including lecturing, consultations with individual students, and supervision of research students;
- Contribute to the development of the curriculum and academic programmes within the discipline and more generally;
- Assume responsibilities for management and administrative tasks associated with the Department, Faculty and University;
- Be an active member of the University and contribute to the work of the University in outreach, collaboration, internationalisation, engagement and policy development.

As Programme Director, the successful candidate will have responsibility for:

- Programme Leadership
- Management and mentoring of staff on the programme
- Liaison with external programme stakeholders, including NEPS, Psychological Society of Ireland (PSI), CORU, Health Service Executive (HSE).
- Liaison with external programme contributors and adjunct members
- Overseeing programme design, revision and development.
- Overseeing the examination process relating to the programme including, student progression, viva examinations and participation in examination board meetings.
- Development of innovative teaching and learning strategies.
- Ensuring that teaching and learning approaches embrace good practices and new developments in educational psychology.
- Upholding and ensuring high ethical standards among staff and programme participants relating to teaching, learning, research and policy.
- Preparation of reports and policy documents.
- Supervision of doctoral level research and building research capacity in educational psychology across Departments of Education and Psychology.
- Teaching on the programme, and other Department of Education and Department of Psychology programmes as directed and agreed by the Heads of the two departments.
- Participation in Departmental and Faculty meetings as required by the Heads of the two departments.
- Attendance and participation in all meetings of Examination Boards.
- Developing the national and international profile of the programme.
- Contributing to outreach and promotional activities, and recruitment and selection of students
- Applying for and supporting other staff to apply for relevant research funding.
- Contributing to the research ethos and activities of the Department of Education and the Department of Psychology, and the Assisting Living and Learning (ALL) Institute.
- Undertaking additional duties as directed and agreed by the Heads of the Departments of Psychology and Education.

The above list is not meant to be exhaustive, but the director and staff on the new programme are expected to work together as a team and in a flexible fashion.

- A doctorate in educational psychology (or cognate area).
- Registration or eligibility to register as an Educational Psychologist with the Psychological Society of Ireland, the British Psychological Society, or an equivalent professional body.
- Specialist current knowledge and expertise in Educational Psychology, and experience of practice as an educational psychologist.
- Experience of administration in an educational psychology context.
- Evidence of leadership and management skills.
- Evidence of having developed a significant research programme, including publications in internationally peer reviewed journals.
- In-depth knowledge of contemporary issues in educational psychology research, practice and policy.
- Evidence of a commitment to promoting social inclusion for marginalised or disadvantaged school students.
- Excellent interpersonal, communication, teamwork, administrative, and organisational skills.
- Understanding of the higher education system.
- Experience of undergraduate and postgraduate teaching, assessment and programme development
- Experience of supervising graduate research students.
- Experience in co-ordination of placements and interaction with multi-stakeholders.
- The ability to build effective relationships with a wide variety of internal and external colleagues.

Faculty and Research Institutes

The Faculty of Science & Engineering comprises the Departments of Biology, Chemistry, Computer Science, Electronic Engineering, Experimental Physics, Theoretical Physics, Mathematics and Statistics, Psychology, Sport Science and Nutrition and the School of Nursing. The role of the Faculty is to co-ordinate the academic activities of individual departments, to oversee the strategic development of departments, and to support interdepartmental activities and programmes. The University has also developed a number of interdisciplinary Institutes to support excellent research and to build research capacity across disciplines, including the Assisting Living and Learning (ALL) Institute.

The Faculty of Social Sciences comprises the Departments of Education, Adult and Community Education; Anthropology; Applied Social Studies; Design Innovation; Economics, Finance & Accounting; Geography; Sociology; the Froebel Department of Primary and Early Childhood Education; and the School of Business and School of Law and Criminology. The role of the Faculty is to co-ordinate the academic activities of individual departments/Schools, to oversee the strategic development of



departments/Schools, and to support interdepartmental programmes. The University has also developed a number of interdisciplinary institutes to support excellent research and to build research capacity across disciplines, including the Maynooth University Social Sciences Institute (MUSSI).

Department

The Department of Psychology provides a number of routes to study psychology including our Psychological Society of Ireland (PSI) accredited, denominated BA/BA (International) and BSc Psychology programmes; offering Psychological Studies as a subject in the joint honours BA degree; a PSI accredited MSc conversion programme, and an MSc in Environmental Psychology. The Department of Psychology has a strong tradition of postgraduate research through structured PhD and MSc research degrees. The Department is a unique and dynamic environment for research; and we are leading globally in several key areas. Our research partners with, and impacts on, individuals and communities, service users and providers, industry, governments, civil society and United Nations agencies. Sstaff members lead the ALL (Assisting Living & Learning) Institute and the Centre for Mental Health and Community Research (CMHCR; our staff are also affiliated to other interdisciplinary research institutes including the Maynooth University Social Science Institute the Kathleen Lonsdale Institute for Human Health Research. We are committed to advancing Equality, Diversity and Inclusion (EDI) in the Department; in 2021, we were successful in securing an Athena SWAN Bronze Award in recognition of our commitment to gender equality.

Department of Education is a dynamic and growing department committed to developing innovative educational ideas, school-university partnerships and close links with the community. It has 22 full-time academic members of staff and it offers undergraduate and postgraduate degrees including Initial Teacher Education for post-primary teachers through Professional Master of Education and Bachelor of Science with Education. The Department's postgraduate offerings focus on professional programmes in Educational Leadership and Education Guidance Counselling and it offers two doctoral programmes: PhD and EdD.
