The Role

Maynooth University is committed to a strategy in which the primary University goals of excellent research and scholarship and outstanding education are interlinked and equally valued.

Our greatest impact on society is through inspiring and educating creative, inquisitive and critically engaged minds. We have a reputation for authentic, strengths-based access initiatives, supporting participation, engagement, and progression for all students.

We recognise that individual student needs vary greatly and that in addition to our universal student supports, dedicated support for complex additional needs is hugely beneficial in ensuring student success. Our Maynooth Access Programme (MAP) Student Advisors are a key part of how we support the access, retention, and success of students from groups identified in the <u>National Access Plan 2022 -2028</u> (NAP) as having low participation in higher education. These groups include students from socioeconomically disadvantaged backgrounds, mature students, further education award holders, lone parents, refugees and protection applicants, care-experienced students, students with disabilities, and members of the Traveller and Roma communities.

MAP Student Advisors provide tailored, student-centred guidance and support through both one-to-one and group settings. They assist students identified in the NAP as having low participation in higher education in navigating university life and conduct individual needs assessments to identify additional supports as needed, to help students thrive. The MAP Student Advisor role involves assessing, coordinating, and ensuring integrated delivery of a broad range of internal and external academic, personal and financial supports, for students from NAP priority groups. MAP Student Advisors work collaboratively with colleagues across the University and with external stakeholders.

Reporting to the MAP Student Advisory Manager within the Maynooth Access Programme (MAP), MAP Student Advisors are based in the Maynooth Access Office as part of a multidisciplinary team that includes outreach and student support professionals, clinical and technical specialists, and administrative staff. While MAP Student Advisors currently report to the MAP Student Advisory Manager, the breadth of engagement with colleagues across the university means that reporting lines can change in line with future organisational/structural reviews and developments as the service expands and develops.

Principal Duties



Administrative and other duties:

- Provide expert guidance and support to prospective and current students identified in the <u>National Access Plan 2022 -2028</u> (NAP) as underrepresented in Higher Education (HE) with the aim of supporting their access, retention, and success.
- Assess the academic and support needs of students, interpreting professional reports and conducting needs assessments to determine reasonable accommodations, assistive technology needs and appropriate supports for students to enable successful learning outcomes.
- Manage a caseload of students, coordinating and monitoring the delivery of supports and accommodations in collaboration with academic and administrative departments.
- Maintain and develop appropriate referral, advocacy, and signposting relationships, both within the University and with external agencies.
- Coordinate the trauma-informed response to students with complex or escalating support needs, contributing to case meetings, liaising with academic and support staff, and ensuring agreed actions are implemented, documented, and followed up.
- Work collaboratively across the University to provide expert advice to staff on the needs of underrepresented students and on creating inclusive learning environments.
- Design, coordinate, and deliver targeted student support initiatives in line with strategic priorities.
 These may include orientation programmes, Open Days, the MAP Mentoring Programme, MAP Academic Advisors, placement support, targeted financial supports, assistive technology, and accessible accommodation.
- Analyse and report on student data using Microsoft 365 and institutional systems, identifying trends, tracking outcomes, and generating insights to inform strategic planning and service delivery.
- Provide feedback on service delivery and contribute to continuous improvement processes in response to evolving and complex student needs.
- Promote student engagement by designing and delivering high-quality workshops, promotional campaigns, and communications across both digital and in-person platforms.
- Contribute actively to institutional strategic projects, partnerships, and policy developments aimed at promoting equity, inclusion, and student success.
- Represent MAP in internal and external forums and professional networks, building strong collaborative relationships and staying informed of sectoral developments.
- Engage in ongoing training and professional development to maintain and enhance expertise in widening participation, student support, and inclusive practice, and to meet relevant competency and compliance standards.

The ideal candidate will have:

- Demonstrated in-depth knowledge of the specific needs of a diverse student population and a strong understanding of the challenges and opportunities involved in increasing participation among equity groups in higher education.
- Knowledge of national widening participation policy, including the *National Access Plan 2022–2028*, and relevant legislation such as the Equal Status Acts and the Disability Act.
- Proven experience supporting individuals from underrepresented or disadvantaged backgrounds.
- Ability to assess academic and personal support needs, interpret professional documentation, and conduct structured needs assessments that result in effective and appropriate supports.
- Demonstrated experience managing complex caseloads and workflows in a fast-paced, studentcentred environment, with strong administrative and documentation skills.
- Proven ability to plan, lead, and evaluate projects independently in a dynamic support or education context.
- Excellent organisational and time-management skills, with a consistent ability to meet deadlines while maintaining attention to detail and accuracy.
- High proficiency in Microsoft 365 tools (including Excel, SharePoint, and Outlook), with experience
 using databases and case management systems to monitor, manage, and report on student
 engagement and outcomes.



- Strong communication, negotiation, and problem-solving skills, with the ability to advocate effectively for students and think strategically under pressure.
- Excellent interpersonal and relationship-building skills, with a proven ability to engage professionally, empathetically, and effectively with stakeholders.
- Ability to work both independently and collaboratively, using initiative, professional discretion, and sound judgement.
- A track record of building and sustaining productive working relationships with a wide range of internal and external stakeholders.

Essential

- A Level 8 degree in a relevant discipline (e.g. Education, Social Work, Psychology, Youth and Community Work, Social Policy, or related field) due to the role's need to understand the higher education environment, navigate complex student needs and make informed professional decisions that deliver impactful support.
- Minimum of 3 years' relevant experience in student-facing support, such as advisory, advocacy, mentoring, or casework supporting students/ individuals from one or more of the National Access Plan priority groups.

Desirable

- A postgraduate qualification in a relevant discipline (e.g. guidance counselling, educational leadership, disability support, social justice), to support advanced knowledge and critical skills in implementing inclusive practice, national policy, and in leading out on student-centred initiatives in a complex higher education environment.
- Experience of assistive technology, particularly as it relates to supporting students with disabilities or additional learning needs in a higher education context.
- Experience of working in an education setting assessing the academic and support needs of students, interpreting professional reports, and conducting formal needs assessments.
- A strong working knowledge of the higher education landscape, including academic programmes, assessment structures, policies, and institutional processes.

Maynooth Access Programme

The Maynooth Access Programme (MAP), established in 1998, delivers on the University's commitment to widening participation and advancing equity in higher education by creating inclusive and enabling learning environments where all students can thrive. Led by the Maynooth Access Office and delivered in collaboration with colleagues across the University and external partners. MAP includes initiatives that increase access, enhance student success, and foster an inclusive campus culture. The programme includes targeted outreach, tailored pre-entry and post-entry supports, and a comprehensive student advisory service for individuals who face social, financial, educational, or disability-related barriers. In line with national policy priorities, including the National Access Plan 2022-2028, MAP supports a wide range of students, including those from socio-economically disadvantaged backgrounds, mature students, further education award holders, lone parents, refugees and protection applicants, care-experienced students, students with disabilities, and members of the Traveller and Roma communities. Maynooth University has developed a strong national reputation for access and inclusion, with 28% of all new undergraduate entrants in 2024–2025 coming from National Access Plan priority groups. The Maynooth Access Office is led by the Director of Access who reports to the Vice President for Equality and Diversity, along with the Equality Officer, the Equality Project Officer, an EDI Data Analyst, Executive Assistants, and the Director of the Centre for Inclusive Higher Education.



The University
